THIS DESPERATELY NEEDED INITIATIVE WAS CREATED IN 2016 IN LOVING MEMORY OF ANGEL, WHO INSPIRED THE SUFP FOUNDATION. SINCE ITS INCEPTION THIS VITAL EFFORT HAS SPAYED AND NEUTERED THOUSANDS OF PIT BULL TYPE DOGS. SPAYING AND NEUTERING ARE REAL AND VIABLE WAYS TO LOWER SHELTER INTAKE AND KILL NUMBERS AND SINCE THE MAJORITY OF ALL DOGS IN U.S. SHELTERS ARE LABELED PIT BULL 'TYPE' DOGS WE REMAIN DEDICATED TO THIS PROGRAM AND WORK TIRELESSLY AT GROWING IT.
