THIS DESPERATELY NEEDED INITIATIVE WAS CREATED IN 2016 IN LOVING MEMORY OF ANGEL THE FOUNDING SOUL WHO INSPIRED THE SUFP FOUNDATION. SINCE ITS INCEPTION THIS VITAL EFFORT HAS SPAYED AND NEUTERED THOUSANDS OF PIT BULL TYPE DOGS NATIONWIDE.
